- Nicole Norvell Division director. Previous role as Director of Special Ed. for Department of Education.
- Learning about structure in DDRS, what's working, what's not working. Continue to work on restructure. New BRS director. Kylie Hope (Atty by trade) also working on charter schools, department of eduction, has a family member with autism who is on the waiver. More emphasis on employment.
- Initiatives- provider meeting on 8/1/13. Will explain where they are going with group home conversions. Rate issues. Health homes (not submitting health homes to CMS), going to do something else.
- Rates- no risk of behavior consultants going away. Is it true, rates may change or be reduced across the board. Thinking about rates differently, doesn't mean an across the board cut. Within 12 months, may see a restructure of rates and submit to CMS. Other states have varying types of rates based on a person's type of care.
- Rate increases- not necessarily going to solve the longer term problem which is the structure in which we provide services.
- Recommend behavior consultants work with lots of different providers, case managers.
- Case managers saying they only need to meet twice a year as a team. Discussion of concerns with case management.
- LOC tool, not 100% determine whether someone meets level of care. Only a piece of the pie.
- Lawsuit between two of the CM companies.

- Client's being able to choose case managers and case management company. Supporting the individual's right to choose their own case manager.
- Group home conversations, waiting lists. group home conversations--- will announce on 8/1/13
- waiting lists--- making progress on the wait list. Five local offices. Why not more rapid progress? Time consuming to explain to family about services (BDDS) to do LOCI. Having a difficult time getting supplemental information. Kids who aren't in public school, there's a lack of documentation (evaluations). Causes a lot of time. High volume. How many people get on and get services at one time (working on gathering that information).
- Targeting 400 consumers a month, 200 getting in process. Not sure how many are getting services.
- Health/homes Not submitting to CMS, doing something else. Will find out on 8/1/13. For consumers who need heath care coordination. Roll out by 1/1/14 Not there (health homes) to roll out. Structure not there.
- Psychiatry- concerns with the disconnection of psychiatrists and providers. Prescribing meds for a psych diagnosis. Justifying use of medication. Has been meeting with the director of DMHA, issues with not serving our population.
- Dual diagnosis committee- psychiatry, BMAN, crisis services. How can we do a better job for our dual diagnosed folks. Partnering better.
- Unavailability of beds, short term, safe place to go. WTS. Not going to happen, at least in the short term.
- WTS was decertified. Partnered with Res-Care, agreed to take over the facility. Carmel facility owned by WTS. Res care transitioned these folks to Marion. All still together. In the interim not accepting new consumers. Carmel facility can house a few more individuals. Res care given permission to open up two more locations.
- Other initiative....performance based provider reimbursement methodology. Some things still floating about...

• Kelly--- looking at complex health issues. Research identified Autism as a complex health care issue that costs a lot of \$. Overuse of ABA services billed through third party insurance. Foundation for complex health care. <u>http://foundation-chs.org</u> Indiana based business.
