  - a. No issues noted. Need committee members. Continued concerns are lack of staffing across the board. In SW Indiana, seeing a reduction of psychiatrists in the area. HRC's needing approval through more than one agency (each agency needing their own approval). Someone with high functioning Autism has been having

  - c. Kelly Hartman would like the committee to gather information about BC's saying they are doing in-home ABA. This is a different service from our waiver service plan. There are other funding services you must go through first. Kayla has also heard CM's telling BCs that they can do ABA services under waiver BC service.

- 7. Partners in Practice Carrie Scherschel no report. Carrie unavailable for update.
- 8. Liaison Kelly Hartman
  - a. Tune in for updates on May 6<sup>th</sup> BDDS will provide hot topics for this session. Kelly will provide what BCs job should be. IF there are topics you want added, please send email to INABC email or to Kelly directly.
  - b. <u>FSSA: DDRS: DDRS Announcements (in.gov)</u> for training link behavior supports training recording available.
  - c. Please look at the case management quality guide. This is what they are working from. Look there first. Kelly will send out the link through INABC.
  - d. State survey (not QOPR) Kelly is unsure what this looks like at this time.
  - e. Questions around rights restrictions. Example, capture history of rights restrictions in plan. Restrictions are happening without the due process path to get there. Relying too much on restrictive interventions. There are times it should be considered. BCs should not be putting restrictions in place without a long history of why.
  - f. Sevita buying out agencies. (Indiana Mentor) It seems they are on a path to take back market share. Smaller companies are finding it easier to join a large system. More than 50% of membership is

- owned by a private entity in California. They have \$ to spend with investors giving \$ to provide. Walmart effect buy less than anywhere else. Cheaper by unit if you buy more.
- g. Agencies that are not part of INABC, in 2016 all were contacted with no additional members added Rob
- h. Appx K will expire 6 months from end of national emergency. Should be July which will then be 6 months after that (December 2022).
- Resource Presentation Hands in Autism Naomi Swiezy Introduction of interdisciplinary training and resource center, IU school of Medicine, HANDSinAutism.IUPUI.edu, <u>nswiezy@iupui.edu</u>, @HANDSinAutism
  - a. Inpatient beds require physician referral. Not a direct line into residential. Year plus intervention not just with individual, resources, modules, etc. After discharge, we are there multiple times per week. Crisis doesn't stop with inpatient stay. Essential for families to know this is intensive, training responders as well.

Of interest: Only 1 agency and 10 independent members have chosen not to renew in 2022. Further, an unprecedented number of new members have joined the association over the last 6 months or so - including 4 or 5 new agencies and 18 new independent consultants.

<sup>\*</sup> Total Funds at this point one year prior, on 4/10/21: \$ 125,742.22

<sup>\*</sup> To accommodate for the growth of small and medium-sized member agencies while maintaining their dues at a static rate, INABC By Laws were updated on December 7, 2021 @ small agencies revised from 6-10x members to 6-15x members, and @ medium-sized agencies from 11-15x members to 16-25x members, while large-sized agencies increased from >16x to >26x members. As a result, while total INABC membership has increased by about 3% thus far in 2022, total membership revenue has decreased by about 11%. Given consistent, and significant, growth since 2019, it seems likely that total membership revenue will return to 2021 levels by 2024, if not before.
